# Congressman Adam Putnam Highlights Banquet

Tropical Storm Fay unfortunately dampened the prospects for a very successful Citrus Expo trade show and seminar program scheduled for August 20-21st, but Congressman Adam Putnam lifted attendees' spirits at the 2008 annual Gulf Citrus Expo Banquet, which was held despite the inclement weather and challenging logistics!

The 2008 Citrus Expo Seminar Program, which was condensed from its originally scheduled two-day format, was held September 4th at two locations, the Citrus Research and Education Center at Lake Alfred, and the Southwest Florida Research and Education Center in Immokalee. Several hundred growers, industry leaders and allied industry representatives participated. Gary Cooper, president of Southeast AgNet/Citrus Industry Magazine/Citrus Expo, tactfully worked with the UF's Institute of Food and Agricultural Sciences (IFAS) to capture the most timely aspects of the seminar program.

This year's banquet featured a video memorial tribute to Mason Smoak, a keynote address by Congressman Putnam, a 60th Anniversary video salute to Florida Citrus Mutual, Florida Department of Citrus highlights and the recognition of "special" industry leaders.

Congressman Adam Putnam, who has been the Florida citrus industry's "go to guy" in Washington, DC, told the audience that despite the economic downturn challenging the nation, "good things" are happening in the nation's Capitol for agricultural "specialty crops."

Focusing on the recent passage of the "Farm Bill," Putnam noted that the new legislation was extremely positive for Florida agriculture as it "institutionalized" a funding source that will benefit the state's "specialty crops" such as citrus. He explained that through the Farm Bill, millions of dollars in "block grants" for research and conservation programs will be made available to producers of fruits and vegetables, beginning this federal fiscal year and for years to come.

The Congressman warned growers of the new wave of "food safety" concerns, citing the recent Food and Drug Administration's (FDA) false implications of "Florida tomatoes" as the source of salmonella contamination, which cost the industry millions. He suggested that the industry continue its "traceability" efforts as a front line defense measure in light of heightened public concerns, and urged the industry to work closer with FDA and other key state and federal agencies to jointly confront food safety issues.

Focusing on Florida agriculture's future leadership, Congressman Putnam told attendees, "Get involved! Join and support your grower organizations! Future agricultural generations will face many new and non-traditional challenges, and your AG associations will be even more important than today."



# "Gulf Citrus" Conducts 22nd Annual Meeting in LaBelle

The Gulf Citrus Growers Association's 22nd Annual Meeting was held June 4, 2008, at the Dallas Townsend Agricultural Center in LaBelle.

GCGA President David Wheeler welcomed the association's members and guests to the meeting which is an "officially specified" session mandated in the organization's by-laws.

Under the "President's Report" David Wheeler thanked the membership and GCGA staff for their support during the past year. He underscored the excellent leadership and interest of the "grower" members, as well as financial commitments of the "associates" and event sponsors. "GCGA events...like the 'Country Gala' and 'Gulf Classic Tournament' help to keep the association's critical governmental affairs and community relations programs funded and effective on behalf of the citrus/AG industry in the 'Gulf' region," Wheeler noted.

Wheeler reported to the membership that the association's leadership is in "transition" from its past "veterans" to its newer, younger leaders. During this period, he noted the importance and value of the "veteran" leaders to stay involved and work with the new leadership to keep the association properly positioned for continued success. He also informed the members that the GCGA leadership was launching a strategic long-range planning initiative in the Fall of 2008 in efforts to "sustain" the organization.

Callie Walker, GCGA Treasurer, reported that the association's board continues to have an annual review of the organization's financial statements each year by a certified accounting firm, and she invited members to review the reports through the GCGA offices.

Ron Hamel, GCGA executive vice president, recognized and thanked the annual meeting luncheon sponsors Southern Gardens Citrus and Syngenta Crop Protection. As part of the "Manager's Report," Hamel and Wheeler presented recognition plaques to the associate members marking 10-years of support (see page 2).

FGCU College of Business professors Drs. Howard Finch and Stuart Van Auken were recognized for their dedicated personal leadership to promote the region's "agriculture" as an important part of the community's economic engine.

Mark Colbert, who served as vice president of GCGA from June 2002-2008, was awarded a "Bill North" oil painting of a citrus grove.

Steve Seibert, executive director of the Century Commission for a Sustainable Florida, was "keynote speaker." Seibert, who also served as Secretary of Florida's Department of Community Affairs under Governor Jeb Bush, highlighted the Commission's 2nd annual report and noted that "agriculture" needs to continue to be a very important part of Florida's future! "But," he stressed "the agricultural community needs to get actively engaged in the conversation."

Seibert reported key "recommenda-

tions" on which the "Commission" will focus: 1) Water for the future needs of all users. 2) Land/Water inter-relationships. 3) Community design and growth into the rural areas. 4) Coordination and cooperation of the various state agencies.

"Most of the state's 'undeveloped' land is in the rural areas and in agriculture," he said. "So your leaders need to be involved."

# **Foundation Annual Meeting**

The GCGA Scholarship Foundation also conducted its annual meeting in conjunction with the "Gulf Citrus" session. Foundation President Norm Todd presided over the meeting, and introduced the other board members: John Hoffman, vice president; Joe English, secretary/treasurer, Callie Walker and David Wheeler.

The membership re-elected Joe English and John Hoffman to three-year terms on the foundation board.

Todd reported that over \$58,000 in student scholarships have been awarded through the program. He recognized the recent recipients and urged attendees to support the effort.

Bernadette Rashford (Bernie) was recently introduced to the GCGA board of directors as a new "part time" employee for the association.

Her responsibilities will include administrative support of the GCGA's events and

growers and ranchers will face not only the challenges with crop production, but increasingly those associated with a growing urban population, including land and water use. Confronting these issues will require greater communications with all sectors of the public like never before," Putnam explained.

"Now is the time to look out to the future, and beyond the immediate crisis and challenge! Future trade deals will be more regional in scope and AG must continue to be at the table. The immigration issue will continue to put more pressure on legal labor sources, and the introduction of mechanical harvesting must be accelerated. And, the environmental issues including water management will intensify," the Congressman noted.

In closing, Congressman Putnam urged the industry to take full advantage of the "specialty crop" provisions in the Farm Bill to invest in the strategic needs important to the future of Florida's producers. "Now is the time to prepare for the future," he said.

Mike Sparks, chief executive officer Florida Citrus Mutual, presented Mutual's 60th Anniversary film which covered the history and accomplishments of the organization.

Ken Keck, executive director of the Florida Department of Citrus, reported on the recent change in the "investment" of Florida citrus grower dollars from the FDOC's traditional marketing programs to production research to confront the immediate threats of the citrus greening and canker diseases. Keck also expressed concerns that the industry cannot allow the demand for Florida's citrus and citrus products to decline to levels that will negatively impact growers' future.

Norm Todd, president of GCGA's Scholar-ship Foundation, reported that over \$60,000 in scholarships have been awarded to deserving students as part of the association's program. Todd also publicly thanked and recognized Dr. Mongi Zekri of the UF/IFAS, the "Gulf" region's multi-county citrus agent, for his years of dedicated service to Florida's citrus growing industry.

GCGA President David Wheeler and Executive Vice President Ron Hamel presented "special recognition" to leaders contributing to the success of the citrus industry. Recognized for their service as chairs of the GCGA's Associate Member Committee were Robert Murray of Wedgworth's, Inc. and Sarah Markle of Valent USA. State Senator JD Alexander was presented GCGA's "Special Recognition for Outstanding Leadership" award for his service to the industry (see story/photo page 8).

# UF/IFAS Southwest Florida HLB Lab Hits 5000 Mark

The HLB Lab located at the UF/IFAS Southwest Florida Research and Education Center (SWFREC) in Immokalee has processed more than 5,000 samples since its opening in February.

The facility represents the state's newest lab dedicated to the Real Time Polymerase Chain Reaction (PCR) molecular diagnosis of Huanlongbing (HLB), commonly known to growers as citrus greening, a bacterial disease transmitted by the Asian citrus psyllid leafhopper. HLB has spread rapidly since first being discovered in Miami in 2005, and citrus groves throughout south and central Florida are at risk of infection. Growers are attempting efforts to control the spread of HLB by using insecticides; however, there is no known cure for the disease and infected trees ultimately will die.

A huge "thank you" goes out to the growers, elected officials, and other industry representatives for their support

in convincing the state legislature to appropriate the \$250,000 in state funds to get the HLB Lab up and running in Immokalee.

The HLB Lab is operated by manager

Paul Julian, who works under the supervision of SWFREC plant pathologist Dr. Pam Roberts. Julian enlists the assistance of other departmental employees on an as-needed basis to prepare samples for diagnosis, which is the most time-consuming part of the diagnostic process. Once DNA extractions are conducted, samples are analyzed in the PCR machine at the rate of nearly 90 per run. The lab currently accepts samples at no charge, a practice that will continue until the state's allocated funding is depleted. Funding beyond the initial start-up amount currently is being sought.

# **Gulf Citrus BMP Report Shows Regional Progress**

Citrus growers in the state's southwest "Gulf" production region continued to aggressively enroll in the Florida Department of Agriculture's Gulf Citrus Best Management Practices (BMP) program during the past year according to the latest report issued by UF/IFAS's implementation team. The "Gulf Citrus BMP Manual" was officially adopted and released in February of 2006 by rule under the Florida Watershed Restoration Act. It serves as the regional citrus grower "menu" of practices aimed at enhancing "on farm" water management activities including water quality and conservation of the resource.

The University of Florida IFAS report for the five-county "Gulf" region indicated that as of October 2008, over 88,000 acres have signed up for the program. The recently released (September 2008) Florida Agricultural Statistical Service's "citrus summary" reported that the region currently has 132,939 total acres of citrus. The 88,489 "participating acres" represents 66.6% of the total acreage in the program.

"The cooperative efforts of the UF/IFAS 'team,' the FDACS' Office of Water Policy, the SW Florida Resource Conservation & Development Council, Hendry Soil and Conservation District and the

Gulf Citrus Growers Association are responsible for continuing to move this program into the implementation phase," said Ron Hamel, executive vice president of GCGA. "Representatives of each of these organizations are 'team players' in the Gulf Citrus BMP program, and we are making excellent progress," he added.

The "cost-share" program, which is tied to specific projects and practices, enables growers to take advantage of state funding. For the 2008-09 budget cycle, FDACS has made an additional \$50,000 available for the program. Citrus growers were sent the Gulf Citrus Cost Share booklet, along with an application form.

This information provides the details for participation. To date, about \$500,000 in cost-share funding has been made available to "Gulf" growers for the Citrus BMP effort.

Geovanne Stinghen has been serving as the UF/IFAS Best Management Practices (BMP) implementation coordinator since the program was launched.
